7:32 pm – Quorum met – Call to order

President's Report – Michael – Lost 2 team in Div 2. Trying APA format in summer for the tournament. Bylaws say 2 season, we are putting together committee to add 3 season to bylaws along with some other housekeeping. Last season league had 7 games not completed due to continual rainouts. Board is working on a budget for the year.

Registrar – Mieko – Discussed adding new players and the process. If merging teams, managers need to transfer via transfer forms. Email format. Team managers need to approve transfers. Deadline for Sunday play is prior Thurs at midnight.

Senior Commissioner Report – 8v8 Tourney to be held Jan 23 & 24 at Meyer. 6 teams added non-team players but have to get TORSO card. Will be using paper rosters. 3 games guaranteed. 30 min halves. 3 women/4men plus goalie.

D&P Report – Ernie & Heather– reminded everyone that all yellow & red cards are reviewed by D&P. Action is usually swift. If anyone has any concerns on the process see the league Constitution Article 9.

Referee Liaison Report – Mark Yanker – Referee evaluations – 27 for fall 2015. 15 negative & 12 positive. 6% negative feedback. 94% of the games were acceptable. League has 2 assignors and assign refs based on availability, location & strength, etc. Evaluations go to the refs and serve as education tools. Managers need to encourage teams to evaluate all. Discussed team colors including having separate colors for home & away and the enforcement. Discussed increasing ref fees to \$65 & 35 which is competitive to other leagues. Working on assignors to ensure all Center Refs pass the test. In all 75% passed – the league goal is 90% pass rate.

Marketing Report – Audrey – Again, like the Facebook page. Working on another ACES clinic.

Scheduler's Report – Fields – Need more fields in the South. Discussed rainouts and process for letting teams & refs know by text before 11am game day. Division 1-3 have an even # of teams meaning no buy weeks. Schedules for first seven weeks up. Rob looking for floater teams who will float home field. Season starts Jan 31. Meyer doesn't open til Feb 22. Weeks blocked for no play this season are Super Bowl, March 13 (spring break), & May 8 (Mothers day) Discussed adding Saturday play.
